In The Township of Toms River Municipal Building, 33 Washington Street, Toms River, New Jersey, the lots, tracts or parcels of lands, hereinafter, specified to make the amount chargeable against, said, lands with interest from the due date to date of Sale and to the close of Sale.

The, said, lands will be struck off and sold to such persons as will purchase the same subject to the redemption at the lowest rate of interest, but in no case to exceed 18 percent per annum. The payment for the Sale shall be made in pursuance of the provision of Title 54: Chapter 5 and the Acts amendatory, thereof, and supplemental, thereto. Industrial properties may be subject to the Spill Compensation and Control Act (N.J.S.A. 58:10A-1 ET SEQ.), and the Industrial Site Recovery Act (N.J.S.A. 13:1K-6 ET SEQ.).
